CREATION OF SCIENTIFIC STORAGE CAPACITY WAREHOUSES

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

(a) the present status of the creation of scientific storage capacity warehouses with allied facilities in rural areas under the Gramin Bhandaran Yojana;

(b) the total number of rural godowns constructed till date and the total number of farmers benefited under this scheme, State-wise including Maharashtra;

(c) the increase of storage capacity derived under the scheme, State-wise;

(d) the amount of subsidy released to various States including Maharashtra during the last three years and the current year for the same;

(e) the number of storage facilities which have been built exclusively for food processing purposes in Maharashtra; and

(f) the extent of the creation of such storage facility in the agriculture and food processing industry?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND FARMERS WELFARE

(a): To develop Agricultural Marketing Infrastructure including Storage infrastructure, Ministry of Agriculture & Farmers Welfare is implementing capital investment subsidy sub-scheme "Agricultural Marketing Infrastructure (AMI)" of Integrated Scheme for Agricultural Marketing (ISAM) with two distinct marketing infrastructure components i.e. (i) Storage Infrastructure in rural area (ii) other than storage infrastructure. The erstwhile two schemes viz. (i) Grameen Bhandaran Yojana (GBY) implemented since 01.04.2001 and (ii) Scheme for Strengthening/Development of Agricultural Marketing Infrastructure, Grading & Standardization Contd...2/-

(AMIGS) implemented since 20.10.2004, have been subsumed into AMI sub scheme. The AMI scheme is presently for the period coterminous with the 14th Finance Commission i.e. upto 2019-20.

AMI scheme is a back ended credit linked and entrepreneur driven scheme, in which rate of subsidy varies from 25% to 33.33% based on the category of eligible beneficiary. Assistance under the sub-scheme is inter-alia available to Individuals, Group of farmers/growers, Registered Farmer Produce Organizations (FPOs) etc.

(b): Since inception of scheme and till 31.12.2018, a total of 38,954 storage infrastructure projects (Godowns) under storage infrastructure component of AMI sub-scheme (erstwhile GBY) of ISAM has been sanctioned. An evaluation study carried out by Global Agri System in their report (2012) titled "Evaluation and impact assessment of Central Sector Scheme of Gramin Bhandaran Yojna" state that a large number of farmers benefit directly and indirectly for the scheme. The state-wise details of rural godowns constructed by eligible beneficiaries including that in Maharashtra is at **Annexure-I**.

(c): Since inception of scheme and till 31.12.2018, storage capacity of 65.49 million MT have been sanctioned under AMI sub-scheme (erstwhile GBY) of ISAM. The state-wise detail of storage capacity derived under the scheme is at **Annexure-II**.

(d): The scheme is for entrepreneurs and demand driven. Hence, no subsidy is released to various states. However, state wise subsidy released for the project is at Annexure-III.

(e) & (f): One of the main objectives of the AMI sub-scheme (erstwhile GBY) of ISAM is to promote creation of scientific storage capacity for storing farm produce, processed farm produce and agricultural inputs etc. to reduce post-harvest & handling losses, promote pledge financing and market access.

The AMI sub-scheme of ISAM is a demand driven scheme and no such demarcation based on the agriculture commodities or produce has been made under the scheme. Since inception of scheme and till 31.12.2018, a total of 3581 storage infrastructure projects, with storage capacity of 6.67 million MT were sanctioned in the State of Maharashtra under AMI sub-scheme (erstwhile GBY) of ISAM.

Further, Ministry of Food Processing Industries, Government of India, is implementing the Central Sector Scheme of Integrated Cold Chain and Value Addition Infrastructure as one of the component of Pradhan Mantri Kisan Sampada Yojana which has one of the objectives of promoting integrated cold chain projects for perishable horticulture and non-horticulture produce.

Total 67 cold chain projects are being implemented in the State of Maharashtra under the Scheme for Integrated Cold Chain and Value Addition Infrastructure.

Till now, 381 Cold Chain Projects have been sanctioned by Ministry of Food Processing Industries, Government of India. Government has also been promoting cold storage through other schemes such as MIDH,AMI & RKVY in addition to Pradhan Mantri Kisan Sampada Yojana. Till 31.03.2018, cold storage with total capacity 36.22 millions MT are there in the country.
