### **Loss Making PSUs**

### 1567: SHRI RAHUL KASWAN, DR. A. SAMPATH AND SHRI LAKHAN LAL SAHU:

Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) the Public Sector Undertakings (PSUs) running in losses along with the details of the losses suffered by such PSUs during each of the last three years and the current year, PSU and State-wise;
- (b) the reasons for the said losses and the corrective steps taken by the Government thereon;
- (c) whether the Government proposes to constitute a high level committee to look into it by engaging various stakeholders before the loss making PSUs are earmarked for disinvestment;
- (d) if so, the details thereof and if not, the reasons therefor;
- (e) whether the Government proposes to set up more PSUs in the country; and
- (f) if so, the details thereof, State/UT-wise including Chhattisgarh?

#### **ANSWER**

### THE MINISTER OF STATE FOR HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI BABUL SUPRIYO)

- (a): As per Public Enterprises Surveys for the year 2016-17 and 2017-18 laid in the Parliament in the respective years, 52 Central Public Sector Enterprises (CPSEs) were incurring losses continuously for the last three years i.e. 2015-16, 2016-17 and 2017-18. Enterprise and State-wise details of losses of these loss making CPSEs is given at annex.
- (b), The reasons for losses differ from CPSE to CPSE. However, some common problems faced by loss making CPSEs include obsolete plants and machinery, heavy interest burden, resource crunch, low capacity utilization, low productivity, surplus manpower, high input cost, non-remunerative prices etc. The Steps taken by Government to revive loss making

CPSEs are (a) financial restructuring such as, conversion of loan into equity, waiver of loan and interest including penal interest, Government guarantee for raising loans, grant of moratorium on payment of interest/loan, (b): business restructuring, such as, formation of joint ventures, merger with another PSE, modernization and improved marketing strategies, human resources management and entering into technology joint ventures or strategic alliances etc.

(c) and (d): NITI Aayog has been mandated to identify the CPSEs for strategic disinvestment. The criteria for strategic disinvestment are not based on profitability. NITI Aayog has classified CPSEs into "high priority" and "low priority" based on (a) National Security (b) Sovereign function at arm's length, and (c) Market imperfections and public purpose, for the purpose of strategic disinvestment. Disinvestment of the minority stake sale of the CPSEs is being done as per the disinvestment policy of the Government.

(e) and (f): The decision to establish more CPSEs in the country including in the State of Chhattisgarh is taken by the concerned administrative Ministries / Departments in consultation with various stakeholders and in line with techno-economic feasibility.
