#### **LOAN WAIVERS IN STATES**

1578. SHRI VIRENDER KASHYAP: SHRI ARJUN LAL MEENA:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether it is true that some State Governments have waived off the farmers' loan in the previous years (2014-17);
- (b) if so, the details thereof and the quantum of amount waived off, State/UT-wise;
- (c) the impact of the loan waivers on the economy of these States;
- (d) whether the farmers have been benefited by such loan waivers;
- (e) if so, the details thereof; and
- (f) the amount spent by the Union Government for waiving of the loans of the farmers in Rajasthan till date?

#### **ANSWER**

MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND FARMERS WELFARE

(a) to (f): Yes, madam. A statement indicating the details of loan waiver announced by the different States during 2014-17 is annexed. Agriculture being State subject, the Union Government has not made any assessment on the impact of loan waivers on the economy of such States who have announced their own loan waiver schemes.

Under the Debt Waiver and Debt Relief scheme 2008, the Union Government announced loan waiver for farmers. As reported by National Bank for Agriculture and Rural Development (NABARD), debt waiver of Rs.52,516 crore was extended to 3.73 crore farmers in the country, including farmers of Rajasthan, under the scheme.
