**Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:**

- (a) the details of funds released to Darbhanga in Bihar under various schemes of the Ministry during the last three years and the current year;**
- (b) whether the funds released under the said schemes have been utilized under the respective schemes;**
- (c) if so, the details of the schemes under which the work has been completed or is near completion; and**
- (d) the reasons for non-completion of the said work?**

**(a) to (c) Urban Development is a State subject. The Ministry of Housing and Urban Affairs facilitates and assists States/Union Territories(UTs), including Bihar, in this endeavour through its Missions- Swachh Bharat Mission-**

**Urban(SBM-U), Atal Mission for Rejuvenation and Urban Transformation(AMRUT), Smart Cities Mission(SCM), and Pradhan MantriAwasYojana(Urban)(PMAY-U) to improve the quality of life in cities and towns covered under these Missions. Under the Missions the Central Government approves the State Plans and provides the Central Assistance(CA) to the States. The projects are selected, designed, approved and executed by the States/UTs and the cities. The State Governments release funds to the cities.**

**Darbhanga city in Bihar is covered under the AMRUT, SBM-U, and PMAY-U. The status of funds released to the city by the State Government and implementation of projects is given in Annexure.**

- (d) These are ongoing works under the Missions which are scheduled to be completed under the Mission Period i.e. 2nd October, 2019 for SBM-U, 31.3.2022 for PMAY-U and 2020 for AMRUT.**
