UNDER CONSTRUCTION ROBs/RUBs/FOBs

1725. SHRI BHEEMRAO B. PATIL:

Will the Minister of RAILWAYS be pleased to state:

- (a) the project-wise details of the under construction Rail Over-Bridges (ROBs), Rail Under-Bridges (RUBs) and Foot Over-Bridges (FOBs) in various States as on date on cost sharing basis, project-wise;**
- (b) the location-wise details of the proposals sent by various State Governments including Telangana for constructing ROBs, RUBs and FOBs at level crossings along with the action taken on each of such proposals; and**
- (c) the Zone-wise details of under construction and new projects identified for constructing ROBs/RUBs/ FOBs during the last three years and the current year along with the details of the funds allocated and utilized and the ratio of contribution of each of the State Governments for each of such projects?**

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF UNSTARRED QUESTION NO. 1725 BY SHRI BHEEMRAO B. PATIL TO BE ANSWERED IN LOK SABHA ON 13.02.2019 REGARDING UNDER CONSTRUCTION ROBs/RUBs/FOBs

(a) & (b): 1640 Road Over Bridges (ROBs) and 159 Road Under Bridges (RUBs) have been sanctioned on cost sharing basis. However, no Foot over Bridge (FOB) has been sanctioned on cost sharing basis in Plan Head-30 (PH-30). State-wise details of sanctioned ROBs/RUBs on cost sharing basis including in the State of Telangana is at Appendix-I.

Proposals for construction of ROBs/RUBs in lieu of Level Crossings (LCs) are normally received at various levels in Zonal Railways from State Government and other Statutory Authorities. After completing various formalities with State Government/Statutory Authorities, regarding the consent for sharing of cost and closure of LCs, proposals received for construction of ROBs/RUBs in lieu of LCs are further processed for their inclusion in Budget. This is a continuous process.

(c) : The Zone-wise details of ROBs/RUBs sanctioned on cost sharing basis and fund allocation and utilization during the last four years are at Appendix-II & Appendix-III respectively.
