PRE-MATRIC/ POST-MATRIC SCHOLARSHIPS

174. SHRI FEROZE VARUN GANDHI:

Will the Minister of TRIBAL AFFAIRS be pleased to state:-

- (a) the details of funds sanctioned/ released and utilized under Pre-Matric/ Post-Matric Scholarship Schemes for ST students during each of the last three years and the current year, State/ UT- wise;
- (b) whether the Government proposes to enhance these scholarship amounts being provided under the scheme and if so, the details thereof;
- (c) whether the Government also proposes any new project to provide higher education and nutritious food to the children of Maoist and Naxal affected areas and if so, the details thereof;
- (d) the details of funds allocated, released and utilized for the National Commission on Scheduled Tribes separately showing the expenditure incurred for each centre during the last three years;
- (e) the details of sanctioned strength and vacant positions across various centres/ offices of the Commission; and
- (f) the number of cases dealt with by the Commission during each of the last three years along with the current status of such cases, State/UT-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF TRIBAL AFFAIRS (SHRI JASWANTSINH BHABHOR)

- (a): The details of funds sanctioned/released and utilized under Pre-Matric/ Post-Matric Scholarship Schemes for ST students during each of the last three years and the current year, State/ UT- wise, are enclosed as Annexure I & II respectively.
- (b): For Pre-Matric Scholarship, amount of scholarship is proposed to be increased to Rs.225/- for the Day Scholar and Rs.525/- per month for Hostellers from existing Rs.150/- and Rs.350/- respectively.
- (c): This Ministry also administers the scheme of Grants under Article 275(1) of the Constitution wherein funds are released towards various sectors like education, health, agriculture and other income generating schemes to 27 State Governments for welfare and development of tribal people in rural areas including Naxal affected areas in the country. Eklavya Model Residential School (EMRS) is one of the components under this scheme. The objective of EMRS is to provide quality middle and high school level education to Scheduled Tribe (ST) students in remote areas. In addition to providing quality education, the ST children are also provided with nutritious food in EMRSs. Besides, fund is also released to State Governments for enhancing the education system and infrastructure by providing hostels, coaching/trainings etc.
- (d): The details of funds allocated/released and utilized for the National Commission on Scheduled Tribes during the last three years is as per Annexure III
- (e): The details of sanctioned strength and vacant positions across various centers/ offices are as per Annexure-IV
- (f): The number of cases dealt with by the Commission during each of the last three years along with the current status of such cases is as per Annexure -V
