177. SHRI RAJIV PRATAP RUDY:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) the details of the number of teacher training institutes operational in the country along with the trainees enrolled and passed in each of the last four years, State-wise/UT-wise, year-wise;
- (b) whether the Government has developed any framework to check the quality of teachers at school and higher education level and if so, the details thereof;
- (c) whether the Government has formulated necessary regulations to provide opportunities to multidisciplinary universities and institutions to offer teacher education programmes and if so, the details thereof; and
- (d) the details regarding central financial assistance released and utilized for implementation of teacher training in the country for the last four years, State/ UT-wise?

A N S W E R MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DR. SATYA PAL SINGH)

- (a) to (c): The State/UT-wise number of teacher training institutions in the country recognised by National Council for Teacher Education (NCTE) as on 03/03/2018, is given at **Annexure-A**. The information with regard to trainees enrolled and passed is not available with National Council for Teacher Education (NCTE). The NCERT has developed a framework for Performance Indicators for Elementary School Teachers (PINDICS) and shared with the states. PINDICS is a framework for assessing teacher performance and providing constructive feedback for further improvement. Likewise, the University Grants Commission (UGC) (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other measures for maintenance of standard in higher education) Regulations, 2010, notified on 30th June, 2010, prescribe an Academic Performance Indicator (API) scheme for performance based appraisal of university and college teachers in the country. As per the provision contained in NCTE Regulations 2014, only composite institutions i.e. higher education institutions offering undergraduate or post graduate programmes of study in the field of liberal arts or humanities or social sciences or sciences or commerce or mathematics or an institution offering multiple teacher education programmes, are eligible to apply for Teacher Education programme(s).
- (d): The consolidated expenditure for implementation of teacher training in the country at the elementary and secondary level, for the last four years, State-UT wise is attached as **Annexure -B**.
