SHARE OF PROFIT IN THE GROSS VALUE ADDED OF THE COUNTRY

212. SHRI RAM MOHAN NAIDU KINJARAPU:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) whether the Government is aware of the skewed growth in the share of profits in the Gross Value Added (GVA) of the country and if so, the details thereof;**
- (b) whether steps have been taken to address the low share of wages in the GVA of the country and if so, the details thereof; and**
- (c) whether the Government has identified or set any targets for growth as well share of wages in the GVA and if so, the details thereof?**

ANSWER

(a): Central Statistics Office, Ministry of Statistics & Programme Implementation releases estimates of National Income covering various parameters like Net National Income, Net Disposable Income of General Government, Net Savings of Public & Private Corporations, Per Capita Income etc. The figures depicting the performance of such parameters at current prices for 2011-12 to 2016-17 are Annexed.

However these estimates do not capture the share of profits as such in the Gross Value Added (GVA) of the country.

(b) & (c): Share of wages is also not captured separately in GVA. The Central Government revises minimum wages for the Scheduled employment from time to time. A notification for revising the minimum wages from Rs 250 per day to Rs 350 per day for unskilled workers in non-agriculture sector was issued on 19.01.2017.
