#### **TARGETS UNDER PMAY**

#### NO. 294 SHRI A.P. JITHENDER REDDY:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the targets fixed under the Pradhan Mantri Aawas Yojana(PMAY) and corresponding achievements since 2014, year and State-wise;
- (b) the number of affordable housing projects sanctioned and number of such projects waiting approval, State-wise;
- (c) the total funds as-well-as per centage, spent on acquiring land for the projects;
- (d) the steps taken/planned to reduce the amount of money spent for acquiring land;
- (e) whether the Government has taken note that incentives of Extra Floor Space Index has resulted in builders increasing the cost of the houses under the project and if so, the cases registered against the builders and the steps taken to mitigate the issue;
- (f) the efforts taken to ensure that the cost for a beneficiary does not increase by 12% due to the GST applied on construction material; and
- (g) the measures put in place to ensure that non-tax-payers, illiterate, poor people lacking formal documents are not deprived of the benefits of Yojana?

#### **ANSWER**

## THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF HOUSING AND URBAN AFFAIRS [SHRI HARDEEP SINGH PURI]

(a) & (b): In pursuance of the Government's vision of "Housing for All" by 2022, the Ministry of Housing and Urban Affairs is implementing Pradhan Mantri Awas Yojana (Urban) [PMAY(U)] since 25.06.2015 for providing assistance to States/Union Territories (UTs) in addressing the housing

requirement of the people belonging to Economically Weaker Sections (EWS), Lower Income Group (LIG) and Middle Income Group (MIG) categories in urban areas.

Since inception of the Scheme, total 15,263 projects have so far been approved for construction of 72,65,763 houses under the PMAY(U), out of which 37,54,871 have been grounded for construction, 14,42,796 have been completed and 13,94,022 have been occupied by the beneficiaries. Statewise financial and physical progress under the PMAY(U) is at Annexure.

Based on their demand for housing under the PMAY (U), the States/UTs formulate project proposals and they are approved by the concerned State Level Sanctioning & Monitoring Committee (SLSMC) which is chaired by the Chief Secretary of the concerned State. After approval from the concerned SLSMC, the States/UTs submit the proposals to this Ministry for approval of central assistance by the Central Sanctioning & Monitoring Committee (CSMC). As the CSMC meets every month, no project proposal as on date is pending in this Ministry.

- (c) & (d): The central assistance is not admissible for acquiring land for housing projects under the PMAY (U).
- (e): As per the PMAY(U) guidelines, the sale price of the houses under Affordable Housing in Partnership (AHP) vertical of the PMAY(U) is fixed by States/UTs factoring in incentives provided by Centre/State/ULB with an objective to make them affordable and accessible to the intended beneficiaries.
- (f): The concessional rate of Goods and Services Tax (GST) of 12% (effective rate of 8% after deducting one-third of the amount charged for the house towards the cost of land) is applicable for house constructed or acquired under the PMAY(U).
- (g): As per the PMAY(U) guidelines, an individual beneficiary is required to submit self-certificate/affidavit as proof of income and Aadhar/Voter ID Card/any other unique identification number or a Certificate from Revenue Authority of beneficiary's native District for availing the benefits under the Scheme.
