PLIGHT OF POTATO FARMERS

460. SHRI SANTOKH SINGH CHAUDHARY:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether the Government is aware that the potato farmers, especially those in Punjab, have been hit by another glut and price decline this year;
- (b) if so, the response of the Government in this regard;
- (c) the steps taken by the Government to help the farmers and stabilise the prices; and
- (d) whether these measures have led to immediate relief for the farmers, if so, the details thereof, if not, the reasons therefor?

ANSWER

(a) & (b): The prices of agricultural produce including potato are determined by supply and demand conditions in the market on a day-to-day basis. As per 1st Advance Estimates 2018-19, production of potato is set to marginally decline over the previous year. A Statement showing production and prices of potato in Punjab and all India average monthly wholesale price of potato is given at Annexure.

Government of Punjab has taken the following interventions like reduction in market fee and rural development fee, reduction in commission of Aarhtiyas, focus on increasing consumption through inclusion in mid day meal and jails etc. and has taken up issues like opening of land routes to wagha border for supply of potatoes to Pakistan thus helping farmers to get remunerative price for their produce.

(c) & (d): Government is implementing Market Intervention Scheme (MIS) for procurement of agricultural and horticultural commodities which are perishable in nature and are not covered under the Price Support Scheme (PSS). The objective of intervention is to protect the growers of these commodities from making distress sale in the event of a bumper crop during the peak arrival period when the prices tend to fall below economic levels and cost of production. The scheme is implemented at the request of a State/UT government which is ready to bear 50 percent of the loss (25 percent in case of North-Eastern States), if any, incurred on its implementation. The extent of total amount of loss to be shared on 50:50 basis between the Central and State Governments.
