CHECK GATES AND TOLL GATES ON NHS

750. SHRI RADHESHYAM BISWAS:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS सडक परिवहन और राजमार्ग मंत्री

be pleased to state:

- (a) the detail criteria of establishment of various check gates on National Highways (NHs) including toll gates throughout the country;
- (b) whether the gates established by the State Governments have been notified by the Union Government;
- (c) if so, the details thereof; and
- (d) the total number of gates existing on the NHs, State/UT-wise including Assam?

ANSWER

(a) to (c) Fee plazas are established on National Highways for collection of user fee as per the applicable National Highways (NH) Fee Rules 1997/2008. Government has notified the National Highways Fee (Determination of Rates & Collection) Rules, 2008 on 05.12.2008, and the said rules, as amended from time to time, are applicable for determination of user fee for the projects executed and bids invited on or after 05.12.2008. For the private funded projects completed before 5th December, 2008 the fee collection is as per the provisions of the National Highways (collection of Fees by any person for the use of Section of National Highways/Permanent Bridge/Temporary Bridge on National Highways) Rules, 1997; and the National Highways (Rate of fee) Rules, 1997. However, NH Fee Rules 2008 are also applicable to public funded projects executed before 05.12.2008. The user fee on a stretch of National Highways is collected as per the individual Notifications published in the Official Gazette by the Central Government. In cases where a particular stretch of National

Highway is entrusted to a State Government/UT, the executing authority of the concerned State Government/UT complies with the notification issued by the Central Government.

(d) As on 31.12.2018, the state-wise details of the number of fee plazas operated on National Highways (NHs) are as under:
