THE MINISTER OF STATE FOR TEXTILES (SHRI AJAY TAMTA)

(a): There are estimated 68.87 no. of artisans in the country. Under Pahchan initiative 23.05 lakh artisans have been mobilized so far. The details of Pahchan identity cards issued to handicraft artisans, state wise including the state of Chhattisgarh are as per **Annexure-I.**

(b): Office of The Development Commissioner (Handicrafts) has a separate scheme namely Direct Benefits to Artisans for Welfare of Artisans in which following components relate to social security.

Mudra Loan with Interest Subvention & Margin Money for Handicrafts Artisans

Under Pradhan Mantri Mudra Yojana (PMMY) Mudra Loan provided upto Rs.10 lakh to income generating micro enterprises engaged in manufacturing trading and services sectors. Mudra Loans are being provided to provide adequate and timely assistance to artisans/weavers at **interest subvention** of 6 % for a period of 3 years to a maximum of Rs.100000/- to meet their credit requirements.

Further to encourage the artisans to avail the facility of MUDRA loan, 20% of MUDRA loan amount is also being provided as **Margin money** in their loan amount not exceeding to Rs.10,000/-. Handicrafts Service Centres are facilitating artisans in availing the credit facility by mobilizing them, creating awareness & submitting applications to the Banks.

Support to Artisans in Indigent Circumstances (Pension Scheme)

This scheme provides Financial Assistance to the aged awardees artisans who are the recipient of Shilp Guru Award/ National Award/ Nation Merit Certificate hold/ State Award in handicrafts and are not less than 60 years of age and their annual income should not be Rs. 50,000 or more. Financial assistance of Rs. 3,500/- p.m. is given to Master Craftsperson in Indigent Circumstances.

Insurance Scheme for Handicrafts Artisans

Bima Yojana for Handicrafts Artisans under Pradhan Mantri Jeevan Jyoti Bima Yojana /Pradhan Mantri Surkasha Bima Yojana for the age group of 18 to 50 years and Modified Aam Admi Bima Yojana for the age group of 51 to 59 years who were enrolled as on June, 2017.

The artisans enrolled under the scheme is provided insurance protection through Life Insurance Corporation of India as per details given below:-

For the age group of 18 to 50 years.

- Rs.2 lakh is payable on beneficiary's death due to any cause, for one year period from 1st June to 31st May.
- Risk coverage available will be Rs.2.00 lakh for accidental death and permanent total disability and Rs.1.00 lakh for partial disability for one year period from 1st June to 31st May.

For the Age group of 51 to 59 years

MOUs with NIOS & IGNOU

A MOU has been signed between Govt. and National Institute of Open Schooling (NIOS) Indira Gandhi National Open University (IGNOU) for collaboration in the area of education for handicraft artisans and their children wherein reimbursement of 75% of the fee for SC/ST/BPL and women artisans is being done.

(c) to (e): The schemes of "National Handicraft Development Programme [NHDP]" & Comprehensive Handicrafts Cluster Development Scheme (CHCDS) are being implemented for the benefit of handicrafts artisans without any problem so far.
