833. SHRI RAVINDRA KUMAR PANDEY:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS सङ्क परिवहन और राजमार्ग मंत्री

be pleased to state:

- (a) whether the Government propose to constitute a separate committee for proper monitoring of Toll Tax being collected at National Highways, if so, the details thereof;
- (b) whether there is any proposal to mobilize funds by giving National Highways projects to the private companies on lease to construct the roads and collect the toll tax;
- (c) whether the Government have identified such projects in which there is potential of private investments:
- (d) if so, the State-wise and project-wise details thereof along with the norms fixed for selection of these projects;
- (e) whether the funds mobilized are likely to be used for construction of highways and early completion of different highways projects in the country; and
- (f) if so, the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS

- (a) No, Madam.
- (b) Cabinet Committee on Economic Affairs (CCEA) authorized National Highways Authority of India (NHAI) to monetize public funded completed National Highway (NH) projects which are operational and are collecting user fee for at least 2 years through the Toll Operate Transfer (TOT) model subject to, approval of the Competent Authority in Ministry/NHAI on case to case basis.

- (c) &(d) Around 75 operational NH projects completed under public funding have been preliminary identified for potential monetization using the TOT Model. The First Bundle of TOT Project has already been started w.e.f. 29.08.2018 after submission of Bid Concession Fee. The detail of TOT Bundle-1 projects is at **Annexure-'A'**. Bids for Second Bundle of TOT Project have also been received in NHAI. The detail of TOT Bundle-2 projects is at **Annexure-'B'**.
- (e) &(f) As per Cabinet approval, funds received from TOT will go to the Consolidated Fund of India (CFI), and be ring-fenced for utilization by NHAI.
