Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether any action has been taken by the Government to upgrade various medical colleges in Kerala under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY);
- (b) if so, the details thereof; and
- (c) the corrective measures taken to upgrade Alleppey medical college?

(a) & (b): Yes. Under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY), various Government Medical Colleges (GMCs) in Kerala have been taken up for upgradation. Details are given in the Annexure.

(c): Government TD Medical College, Alappuzha has been taken up for upgradation under Phase-III of PMSSY at a total cost of Rs. Rs. 173.18 Crore (Central share: Rs. 120 Crore; State share: Rs. 53.18 Crore). Scope of work includes construction of 279 bedded Super Speciality Block including 62 ICU beds with 8 OTs and procurement of medical equipment.
