- (a) whether the Rashtriya Madhyamik Shiksha Abhiyan scheme has been introduced across all States/UTs of the country;
- (b) if so, the details thereof;
- (c) the salient features of the scheme and the status of its implementation;
- (d) the total number of new schools that have been set up and the total number of existing schools that have been strengthened, State/UT-wise; and
- (e) the total funds allocated under the scheme, State/UT-wise?

STATEMENT REFERRED TO IN REPLY TO PARTS (A) TO (E) OF LOK SABHA STARRED QUESTION NO. 205 TO BE ANSWERED ON 8TH JULY, 2019 ASKED BY DR. (PROF.) KIRIT PREMJBHAI SOLANKI REGARDING "RASHTRIYA MADHYAMIK SHIKSHA ABHIYAN"

The Centrally Sponsored Scheme of Rashtriya Madhyamik Shiksha Abhiyan (RMSA) was under implementation since 2009 to 2017-18 for universalizing secondary education in the country. RMSA programme provided a number of incentives to encourage enrolment and retention of children in schools as well as for improvement of quality of education. These included enhancing access to secondary schools, strengthening school infrastructure like school building, additional classrooms, laboratories, libraries, arts & craft rooms, toilets, drinking water facilities etc.

The RMSA scheme along-with Sarva Shiksha Abhiyan (SSA) and Teacher Education (TE) have been subsumed under an Integrated Centrally Sponsored Scheme for School Education-Samagra Shiksha which has been launched from 2018-19. It is an overarching programme for the school education sector extending from pre-school to class XII and aims to ensure inclusive and equitable quality education at all levels of school education.

The major features of Samagra Shiksha are as under:-

- (i) Universalizing access to quality school education by expansion of schooling facilities in the uncovered areas through up-gradation of schools up-to senior secondary level.
- (ii) Ensuring availability of adequate infrastructure to ensure that schools conform to the prescribed norms.
- (iii) Annual Grant of Rs. 5,000 to Rs. 20,000/- per school for strengthening of Libraries.
- (iv) Composite school grant of Rs. 25,000-1 Lakh to be allocated on the basis of school enrolment, out of which at-least 10% is to be spent on Swachhta Action Plan.
- (v) Annual Grant for sports equipments at the cost of Rs. 5000 for Primary Schools, Rs. 10,000 for upper primary schools and up to Rs. 25,000 for secondary and senior secondary schools.
- (vi) Allocation for children with Special Needs (CwSN) of Rs. 3,500 per child per annum including a stipend of Rs. 200 per month for CWSN girls to be provided from Classes I to XII.
- (vii) Allocation for uniforms at the rate of Rs. 600 per child per annum.
- (viii) Allocation for textbooks at the rate of Rs. 250/400 per child per annum.
- (ix) Upgradation of Kasturba Gandhi Balika Vidyalayas (KGBVs) from Class 6-8 to Class 6-12.
- (x) Strengthening Teacher Education Institutions like SCERTs and DIETs to improve the quality of teachers.

- (xi) Enhanced use of digital technology in education through smart classrooms, digital boards and DTH channels.
- (xii) Support States & UTs for implementation of provisions of RTE Act, including reimbursement under Section 12(1)(c) of the Act.
- (xiii) Setting up of residential schools and hostels for difficult areas and for children in difficult circumstances.

Under erstwhile RMSA till 2017-18 and Samagra Shiksha effective from 2018-19, 12,896 new secondary schools, 53,789 additional classrooms, 66,286 toilets and 11,933 drinking water facilities have been sanctioned, out of which States and UTs have reported that 12100 new schools have become functional and construction of 8663 new schools, 37,546 additional classrooms, 46,280 toilets and provision of drinking water facility in 10,093 schools has been done till 31.03.2019. Besides this, approval has been given for up-gradation of 44 Secondary schools to senior secondary and introduction of new stream in 851 senior secondary schools under Samagra Shiksha in 2018-19.

State and UT-wise Secondary and Higher Secondary schools approved under erstwhile Scheme of RMSA upto 2017-18 and Samagra Shiksha in the year 2018-19 is at **Annexure-I**. The Central share is released to States and UTs as per their approved Annual Work Plan & Budget (AWP&B) subject to the pace of expenditure, submission of the required documents and the availability of budget.
