- (a) the details of the total number of farmers and mandis registered with e-NAM, State/UT-wise;
- (b) whether the Government has faced any challenges in the implementation of the scheme specifically regarding internet connectivity and infrastructure; and
- (c) if so, the steps taken by the Government to address the challenges and expedite the implementation and coverage of the scheme?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF LOK SABHA STARRED QUESTION NO. 228 DUE FOR REPLY ON 9TH JULY, 2019.

- (a): Government of India has launched National Agriculture Market (e-NAM) Scheme on 14th April, 2016 with the objective of creating online transparent competitive bidding system to facilitate farmers with remunerative prices for their produce. So far, 585 wholesale regulated markets of 16 States and 02 Union Territories (UTs) have been integrated with e-NAM platform and till 30.06.2019, a total of 1,64,51,587 farmers have been registered under this scheme. The State-wise details of farmers registered & mandis integrated with e-NAM is annexed.
- (b) & (c): Availability of the desired speed of internet connectivity in few mandis situated in remote areas is a challenge.

State Governments have been advised to explore the possibilities of upgrading the internet connectivity with internet service providers. States have also been advised to provide sufficient computers & other hardwares with requisite manpower. Close monitoring of the progress through meetings at various levels and visits of the officers to e-NAM mandis is carried out. The Central Government is providing free software and assistance for related hardware including quality assaying equipments and creation of infrastructure like cleaning, grading, sorting, packaging and compost unit etc. Under the scheme, various training & awareness programmes are conducted for farmers, traders, commission agents and other stakeholders for successful implementation of e-NAM. Various steps taken by the Government has led to inter-mandi and inter-State trade on e-NAM Platform.
