- (a) the number of Bharat Sanchar Nigam Limited (BSNL) mobile towers installed across the country along with the details of the services/facilities these are equipped with, State-wise including Haryana and the district-wise details of Gujarat State;
- (b) whether most of the BSNL mobile towers in Gujarat and Haryana are equipped to provide 2G services whereas mobile towers of other private telecom companies are providing 4G services and if so, the details thereof;
- (c) whether the Government proposes to upgrade the BSNL mobile towers installed across the country including Gujarat, particularly in Bhavnagar and Botad districts;
- (d) if so, the details thereof and the steps taken by the Government in this regard along with the time by which the said upgradation is likely to be done and if not, the reasons therefor; and
- (e) the number of mobile towers upgraded in Gujarat during each of the last three years and the current year?

(a) Bharat Sanchar Nigam Limited (BSNL) is providing 2G, 3G and 4G (at few locations) mobile services in its Licensed Service Areas (LSAs). State-wise detail of 2G, 3G and 4G Base Transceiver Stations (BTSs) installed by BSNL across the country including Gujarat and Haryana is at **Annexure-I.**

District-wise details of BTSs installed by BSNL in Gujarat State is at Annexure-II.

(b) As on 31.05.2019, 4852 number of 2G BTSs, 3163 number of 3G BTSs and 844 number of 4G BTSs of BSNL are working in Gujarat State. As on 31.05.2019, 2237 number of 2G BTSs, 2236 number of 3G BTSs and 170 number of 4G BTSs of BSNL are working in Haryana State. Details of BTSs installed by BSNL and major private Telecom Service Providers (TSPs) in Gujarat and Haryana as on 31.05.2019 are as under:
