Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

- (a) the details of the production and export of marine and aquaculture products in the country during the last five years and the current year, year and State-wise;
- (b) whether it is true that the Government has approved Fisheries and Aquaculture Infrastructure Development Fund (FAIDF);
- (c) if so, the aims and objectives of the Fund;
- (d) the extent to which the Fund has helped/will help in creating critical infrastructure, technology infusion, marketing, etc. in major marine and aquaculture producing States like Andhra Pradesh; and
- (e) the estimated number of employment opportunities which would be created through utilisation of this Fund, State-wise along with the extent to which FAIDF would help in Blue Revolution?

ANSWER

**Statement referred to in reply to the Lok Sabha Starred Question No.*438 put in by
Shri Balashowry Vallabhaneni, Member of Parliament for answer on 23rd July, 2019
regarding Marine and Aquaculture Products**

(a) : State-wise details of the fish production and export of marine and aquaculture products in the country during the last five years are furnished at Annexure-I and Annexure-II respectively.

(b) to (e) : Yes, Sir. In order to address the infrastructure requirement for fisheries sector, the Government of India during 2018-19 a created dedicated fund namely Fisheries and Aquaculture Infrastructure Development Fund (FIDF) with a total funds size of Rs 7522.48 crore with the objectives of creation and modernization of inland and marine fisheries infrastructure, infrastructure support for improving domestic marketing facilities and to bridge the resource gap and facilitate completion of ongoing infrastructure projects.

The FIDF provides concessional finance to the Eligible Entities (EEs), including State Governments/Union Territories and State entities for development of identified fisheries infrastructure facilities. The concessional finance is provided by the Nodal Loaning Entities (NLEs) namely (i) National Bank for Agriculture and Rural Development (NABARD), (ii) National Cooperatives Development Corporation (NCDC) and (iii) All scheduled Banks. Under the FIDF, the Government of India provides interest subvention up to 3% per annum for providing concessional finance by the NLEs at an interest rate not lower than 5% per annum.

The infrastructure facilities envisaged under FIDF for the benefit of fisheries sector in all the States/Union Territories including Andhra Pradesh are: establishment of fishing harbours and fish landing centres, ice plants, cold storages, fish transport and cold chain network infrastructure, modern fish markets, setting up of brood banks and hatcheries, development of aquaculture and mariculture, modernization of state fish seed farms, state of art fisheries training centres, fish processing units, fish feed mills/plants, establishment of cage culture in reservoirs, introduction of deep sea fishing vessels, establishment of disease diagnostic laboratories, and aquatic quarantine facilities etc. FIDF aims to achieve a sustainable growth of 8-9 per cent, in a move to augment the country's fish production and generate both direct and indirect employment opportunities to over 9 lakh persons in fishing and allied activities.
