Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the names of the States where the Union Government has implemented “Sakhi Kendra” Yojana;
- (b) the details of centres presently operational, out of the sanctioned/approved projects in the country during the last three years;
- (c) whether a “Sakhi Kendra” has been sanctioned in Deoli of Wardha district of Maharashtra;
- (d) if so, the details thereof along with the time by which it will become operational; and
- (e) if not, the reasons therefor?

ANSWER

- (a): The Government of India has approved the One Stop Centre (OSC) scheme across the country in all the States/Union Territories. The names of the States where One Stop Centre-Sakhi is being implemented by the States/Union Territories is at **Annexure-I**.
- (b): So far 506 OSCs are reported to be operational as against 728 centres approved. Details are at **Annexure-II**.
- (c) & (d): One Stop Centre has been sanctioned for Wardha district in Maharashtra and is reported to be operational since 03.10.2018.
- (e): Does not arise.
