AIIMS IN KERALA

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

(a) the present status of establishing All India Institute of Medical Sciences (AIIMS) like institutions in various States, the details of institutes sanctioned, funds allocated, utilized and the works completed;

(b) the reasons for not including Kerala in the earlier phase of announcing AIIMS in various States;

(c) whether the Government is considering any new proposal for AIIMS, if so, the details thereof, State-wise;

(d) whether the Government has received any pending proposal from Kerala for establishing AIIMS; and

(e) if so, the details thereof and the present status of the same?

**ANSWER

(a): 22 new AIIMS have been approved/announced by the Union Government in various parts of the country. Of these, six new AIIMS in Patna (Bihar), Raipur (Chhattisgarh), Bhopal (Madhya Pradesh), Bhubaneswar (Orissa), Jodhpur (Rajasthan) and Rishikesh (Uttaranchal) are functional.

Details of the new AIIMS can be seen at Annexure.

(b): Hon'ble Finance Minister, while presenting the Budget for the financial year 2014-15, had announced setting up of four new AIIMS in Andhra Pradesh, West Bengal, Maharashtra and Purvanchal in UP, and in the Budget speech 2015-16, had announced to set up six new AIIMS in Jammu & Kashmir, Punjab, Tamil Nadu, Himachal Pradesh, Assam and Bihar. AIIMS in Gujarat and Jharkhand have been announced in Budget of 2017-18. AIIMS in Haryana has been announced in the interim Budget 2019-20.

However, AIIMS in Kerala has not been included in any of budget announcements so far.

(c): New AIIMS are established as and when they are announced in various Budget speeches.

(d) & (e): Govt. of Kerala identified following four locations for setting up AIIMS in Kerala:

- i. Thiruvananthapuram district- Kattakada taluk, Kallikadu village, Block 31, Resurvey 66.
- ii. Kottayam district- Arpookkara, Athirampuzha and Peraicakadu villages.
- iii. Ernakulam district- Block No.5, 717/5, Block No.6, 321/1
- iv. Kozhikode district- Kinalur and Kanthalad villages in Panangad Grama Panchayath, Thamarassery taluk.

However, AIIMS for the State of Kerala has not been announced so far.
