Will the Minister of FINANCE be pleased to state :

- (a) whether the Government has sanctioned/allocated funds under the Credit Guarantee Scheme, Credit Linked Capital Subsidy Scheme and other credit schemes during the last four years ;
- (b) if so, the details thereof, State-wise; and
- (c) if not, the reasons therefore ?

(Smt. Nirmala Sitharaman)

(a) to (c) : Government allocates / sanctions funds, periodically, under Credit Guarantee Scheme and Credit Linked Capital Subsidy Scheme (CLCSS) and other credit schemes to enhance availability of credit at competitive rates. Credit Guarantee Schemes are implemented across the country. There is no specific State-wise bifurcation of the corpus.

The details of funds allocated to various Credit Guarantee Schemes are placed at **Annexure I**. State-wise details of subsidy provided under CLCSS during the last four years is placed at **Annexure II**.
