New Education Policy

1543. SHRI P.V. MIDHUN REDDY: SHRI ADHIR RANJAN CHOWDHURY:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether the draft Education Policy 2019 has been submitted by the Committee led by Dr. Kasturirangan and is placed for views of the general public;
- (b) if so, the details thereof and the recommendations made by the Committee therein;
- (c) the details of important changes/additions incorporated in the draft Education Policy;
- (d) whether the Government proposes to consider all the changes/additions/suggestions made in the draft Education Policy and if so, the details thereof and if not, the reasons therefor; and
- (e) the steps taken/ being taken by the Government to improve the overall quality of the education sector in the country?

ANSWER

(a) to (d): Yes Sir. The Committee for the Draft National Education Policy under the Chairmanship of Dr. K. Kasturirangan has submitted its report to the Ministry on 31st May 2019. The draft NEP 2019 has been uploaded on MHRD's website and also at innovate.mygov.in platform to elicit suggestions/comments from all stakeholders including the public, Government of India Ministries and State Governments. Several reform measures have been proposed in the Draft NEP 2019, so that all students have equitable access to quality education across the country. The Government will finalize the National Education Policy only after considering the inputs/suggestions and comments of all stakeholders.

(e): Improving the quality of education across all levels from primary to university level is a continuous and ongoing process. Several initiatives are currently being undertaken in this direction. The Samagra Shiksha, an integral scheme for School Education as a Centrally Sponsored Scheme is being implemented throughout the country with effect from the year 2018-19. This programme subsumes the three erstwhile Centrally Sponsored Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha (RSMA) and Teacher Education (TE). It is an overarching programme for the school education sector extending from pre-school to class XII and aims to ensure inclusive and equitable quality education at all levels of school education. It envisages the 'school' as a continuum from pre-school, primary, upper primary, secondary to senior secondary levels.

In higher education also, various schemes, namely, Rashtriya Uchchatar Shiksha Abhiyan (RUSA), Scheme for promotion of Academic and Research Collaboration (SPARC), Global Initiative for Academics Network (GIAN), Impacting Research, Innovation & Technology (IMPRINT), Technical Education Quality Improvement Programme (TEQIP), Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching (PMMMNMTT), Study Webs of Active-Learning for Young Aspiring Minds (SWAYAM), National Digital Library, campus connect programme, Uchhatar Avishkar Abhiyan, Unnat Bharat Abhiyan, Impactful Research in Social Sciences (IMPRESS), Atal Ranking of Institutions on Innovation Achievements (ARIIA) are being implemented to improve the quality of higher education. A number of initiatives are also undertaken by UGC and AICTE for quality improvement in higher and technical education.
