Assistance for Deep Sea Fishing

1750. SHRI SUNIL KUMAR MONDAL:

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING
मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state:

- (a) the details of the steps taken to ensure safety of fishermen fishing in the deep sea and the assistance provided to them for marketing of their catch;
- (b) whether the Government has any plan to set up new fishery harbours in different States along coastal areas;
- (c) if so, the details thereof along with the new proposals in this regard, State-wise; and
- (d) the fund allocated/released/utilized for this purpose during each of the last three years, State-wise?

ANSWER

THE MINISTER OF STATE FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING:

(a) to (d): To ensure the safety of fishermen at sea, the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying under the Centrally Sponsored Scheme (CSS) on Blue Revolution: Integrated Development and Management of Fisheries provides assistance to the Coastal State Governments/Union Territories for providing safety kits to fishermen. The safety kits provided under the CSS consists of GPS, communication equipment, echo-sounder, lifejackets, lifebuoys, Distress Alert Transmitter (DAT), life-saving appliances (VHF radiotelephones), fish finder, backup battery, search & rescue beacon etc. Besides, necessary training is provided to fishermen for safe navigation and seamanship of fishing vessels through the Central Institute of Fisheries Nautical Engineering and Training Institute (CIFNET) functioning under the Department of Fisheries. The CSS also provides financial assistance for construction of fish markets and allied infrastructure including cold storage facilities, mobile/retail fish outlets, refrigerated and insulated trucks for safe transport of marketing of fishes. The CSS on Blue Revolution: Integrated Development and Management of Fisheries *inter-alia* provides financial assistance to the maritime State Governments and Union Territories (UTs) for (i) construction of new fishing harbours and fish landing centres and (ii) Up-gradation/expansion/repair/renovation of the existing fishing harbours and fish landing centres. Besides, the CSS also provides suitable convergence with the Sagarmala of Ministry of Shipping for development of fishing harbours and fish landing centres. Details of proposals approved under the CSS during the past four years (2015-16 to 2018-19) for construction of new fishing harbours/fish landing centres including modernization of the existing ones under CSS are furnished at **Annexure-I**. State-wise details of the funds released during last three years for construction of fishing harbours/fish landing centres including modernization of the existing ones are furnished at **Annexure-II**.
