(a) & (b): Agriculture being a State subject, the State Governments undertake development of perspective plans and ensure effective implementation of the programmes/ schemes. Also, Government of India supplements the efforts of the State Governments through various Schemes/ Programmes. The Government has been reorienting the agriculture sector by focusing on an income-centric approach as against the earlier production centric policy. This focuses on achieving high productivity, reduced cost of cultivation and remunerative price on the produce, with a view to earning higher profits for the farmers. A list of various schemes inter-alia implemented by the Government is **annexed**.

Further under Mission for Integrated Development of Horticulture (MIDH) scheme, assistance for development of Post-Harvest Management (PHM) for establishment of cold storages, staging cold room, pack house, pre-cooling units, controlled atmosphere (CA) storage, reefer vans, primary/mobile processing units, integrated pack house, preservation unit (low cost), ripening chambers, onion storage at farm level etc. is provided for safeguarding agriculture produce.
