No. 2175 SHRI MANOJ KOTAK:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the estimates of slum population across the country, Statewise especially in Mumbai;
- (b) the steps taken by the Government to collect surveys pertaining to slums between successive censuses;
- (c) the number of low-cost housing complexes constructed by the Government during the last five years especially in Mumbai; and
- (d) the number of such houses that continue to remain vacant?

ANSWER

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF HOUSING AND URBAN AFFAIRS

(SHRI HARDEEP SINGH PURI)

(a) : As per the population Census of India 2011, the estimated slum population across the country is 6,54,94,604, including 52,06,473 in Municipal Corporation of Greater Mumbai. State/Union Territory (UT)-wise details of slum population are at Annexure-I. (b): The Ministry of Housing and Urban Affairs (MoHUA) does not conduct any specific survey pertaining to slums between successive censuses. However, the MoHUA through its programmatic intervention Viz. Pradhan Mantri Awas Yojana (Urban) {PMAY(U)} Mission has been making overarching efforts in providing housing with basic civic amenities to the urban poor including slum dwellers of towns/cities of the country by assisting States/UTs both technically and financially.

(c) & (d): The details of number of houses sanctioned, grounded, completed and unoccupied during the last five years are enclosed at Annexure-II.
