(a): In 2018-19, no import of pulses was undertaken by the Government.

(b) : As per the 3rd Advance Estimates released by Department of Agriculture, Cooperation and Farmers Welfare, production of pulses for the year 2018-19 is estimated to be 23.22 Million MT (MMT) as compared to final estimates of 23.13 MMT and 25.42 MMT for the years 2016-17 and 2017-18, respectively.

(c) : Details of major exporting countries of pulses to India is at Annexure.
