Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether the Government is contemplating on the extension of grazing grounds in the country;
- (b) if so, the details thereof, State-wise/district-wise;
- (c) whether the Government is considering/proposes to ensure the availability of grazing ground at the gram panchayat level;
- (d) if so, the details thereof; and
- (e) if not, the reasons therefor?

ANSWER

(a) & (b): There is no such information available with this Ministry. As per the available report in Land Use Statistics At a Glance June, 2017, by the Directorate of Economic & Statistics, Ministry of Agriculture and Farmers Welfare, the area under Permanent pasture and other grazing land in the country is 10258 thousand ha. The State-wise area under permanent pasture & other grazing land in the country is **annexed.**

Ministry of Fisheries, Animal Husbandry and Dairying is implementing a centrally sponsored scheme namely, National Livestock Mission in all States and UTs wherein financial assistance is provided for fodder production under the component Fodder Production from Non-Forest wasteland/rangeland/grassland/non arable lands. Besides, Additional Fodder Development Programme (AFDP) a sub-scheme of Rashtriya Krishi Vikas Yojana (RKVY) is implemented by Ministry of Agriculture & Farmers Welfare for enhancing the availability of fodder for livestock rearers.

- (c): The State governments are free to implement such programmes & access the central funds detailed in (b) above, for the purpose.
- (d) & (e): Do not arise.
