#### YUVA SAHAKAR SCHEME

2695. SHRI MOHANBHAI KALYANJI KUNDARIYA:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether National Cooperative Development Corporation (NCDC) has launched a new scheme 'Yuva Sahakar', giving wings to young entrepreneurs in cooperatives;
- (b) if so, the details thereof and the number of young entrepreneurs benefitted in Gujarat, district-wise;
- (c) whether the National Cooperative Development Corporation (NCDC) has provided loan/incentive/subsidy to cooperative institutes for development of cooperative infrastructure in the country; and
- (d) if so, the details of such assistance/funds given by the Government to the said institutes during each of the last three years and the current year, institute and State/UT-wise?

#### **ANSWER**

MINISTER OF AGRICULTURE AND FARMERS WELFARE

- (a): Yes Sir, National Cooperative Development Corporation (NCDC) has recently launched 'Yuva Sahakar' Scheme to support young entrepreneurs through Cooperatives.
- (b): The details of the scheme are given at **Annexure-1**.

No Cooperative from Gujarat has so far applied for assistance under the scheme 'Yuva Sahakar'.

NCDC is an ISO 9001:2015 compliant organisation and has a distinctive edge of competitive financing. NCDC has disbursed over Rs.61,000 crore in the last 4  $\frac{1}{2}$  years which amounts to more than 57% of its cumulative disbursements since 1963.

NCDC has simplified financial system process, which can be accessed through its 18 Regional Offices or Head Office in New Delhi. NCDC has attractive funding spectrum offering a diverse range of financial products for a wide canvas of activities to all types of Cooperatives at all levels to the State Government as well as Direct Finance.

NCDC is the most preferred financial institution in the sphere of cooperatives and aligning itself with the Mission of New India 2022, NCDC has embarked on Sahakar 22, a Mission for Doubling Farmers' Income by 2022.

#### **Cooperative Enterprise Support and Innovation Scheme**

#### **Objective**

NCDC has taken its cue from the Government programmes like Start-up India and Stand-up India which is now a guiding spirit towards youth and entrepreneurs. India is recognized as one of the most happening countries in the areas of innovation and start-ups. Ease of doing business coupled with emergence of nonconventional business opportunities are driving the economy. The conducive investment climate is being leveraged by private and corporate sectors and hub start-ups are being promoted. To encourage cooperatives to be part of this momentum, NCDC introduces the scheme "Cooperative Enterprise Support and Innovation Scheme".

The Scheme is open to Cooperative Societies in the Country and the action plan of this initiative, is based on the scheme being simple, inclusive, liberal with concessional funding support. This initiative aims to encourage newly formed cooperatives to take advantage of innovative ventures, especially by societies having new/innovative idea. The Scheme will be linked to a Cooperative Startup and Innovation Fund (CSIF) created by NCDC with an annual outlay Rs.100.00 crore. The Scheme would be liberal to Cooperatives in North Eastern Region, Cooperatives registers and operating in Aspirational Districts identified by Niti Aayog, cooperatives with 100 % women members and cooperatives with 100 % SC / ST / PwD members

#### SALIENT FEATURES

#### Eligibility

- a) All types of cooperatives with new, innovative and value chain enhancement intended projects.
- b) In operation at least for one year.
- c) Have positive net-worth.
- d) Have not incurred cash loss during previous year(s) of operation and no cash loss in the past three years (if the society is in operation for more than 3 years).

#### **Project Cost**

Project cost not exceeding Rs.3.00 crore.

#### **Loan Period**

Period of loan is up to 5 years, including 2 years moratorium on payment of principal. Period of moratorium may vary, depending of type of project and ability to generate revenue.

#### **Rate of Interest**

As an incentive, 2.00% less than the applicable rate of interest on term loan for the project activities. Interest incentive is applicable only for timely repayments.

#### **Security**

The societies may offer security for the loan in any one or combination of the following to the satisfaction of NCDC:

- a) Mortgage of assets, including assets to be created under the proposed project.
- b) FDRs of the scheduled banks.
- c) Guarantee of credible cooperative institutions, i.e., the institution which has sound financial condition and proven track record.
- d) Guarantee of State/Central Government
- e) Guarantee by Central PSUs/ Statutory bodies/CSR Foundations of Central PSUs.
- f) Guarantee of Small Farmers' Agri Business Consortium (SFAC)/ North Eastern Development Finance Corporation (NEDFi)/ Small Industries Development Bank of India (SIDBI)

#### Subsidy:

In case subsidy is eligible for the proposed activity under the Central Sector Integrated Scheme on Agricultural Cooperation (CSISAC) or any other source, the same will be applicable. To ensure speedy & smooth implementation of projects eligible loan shall be provided in-lieu of subsidy and the subsidy, as and when received, would be adjusted against the loan account.

#### **Funding Pattern:**

The projects would be supported with funding pattern having **Debt:** Equity Ratio as below:

#### Category-A:

80%: 20% All types societies in North Eastern region.

All types of cooperatives registered and operating in

Aspirational Districts identified by Niti Aayog.

All types of cooperatives with 100 % women members.
All types of cooperatives with 100 % Scheduled Caste / Scheduled Tribe / Person(s) with disability (PwD) members

#### Category-B:

70%: 30% In normal areas in case of all the Cooperative not covered

under Category-A for all types of activities.

In case subsidy is eligible for the proposed activity, subject to availability, the loan component would be reduced proportionately.
