### 2717. SHRI NIHAL CHAND:

Will the Minister of CHEMICALS AND FERTILIZERS, be pleased to state:

(a) the details of medicines and diseases for which medicines are being provided under the scheme formulated to sell medicines through Pradhan Mantri Jan Aushadi Kendras;

(b) the details of the progress under the Pradhan Mantri Bhartiya Jan Aushadi Pariyojana at present and the details of the plans being formulated for its expansion in future;

(c) the number and details of centres set up across the country so far under the said scheme, State/UT-wise; and

(d) the manner in which the number of such centres are likely to be increased in future?

# ANSWER

# MINISTER IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI D. V. SADANANDA GOWDA)

(a) A total of 900 drugs and 154 surgicals and consumables are currently included in the product basket of Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP). The list of therapeutic group-wise number of medicines included in the product basket of PMBJP is enclosed as **Annexure-I.** The detailed list of medicines/surgicals is available at website janaushadhi.gov.in.

(b) The statement of the progress achieved so far under the PMBJP is enclosed as **Annexure-II**. In the current financial year the plan is to open 1200 new PMBJP Kendras in the country.

(c) The list of State/UT-wise number of PMBJP Kendras set up across the country as on 03.07.2019 is attached as **Annexure-III**. The detailed list of PMBJP Kendras opened across the country so far is available at website <u>janaushadhi.gov.in</u>.

(d) The number of PMBJP Kendras will be increased by opening more such Kendras on receipt of applications from interested and eligible entrepreneurs.
