Will the Minister of **COMMERCE AND INDUSTRY** be pleased to state: वाणिज्य एवं उदयोग मंत्री

- (a) whether India has moved to top ten FDI hosting countries in the last three years;
- (b) if so, the details of projects, MoUs signed during the last three years and the actual progress made so far in this regard;
- (c) whether it is a fact that during the last three years the average FDI inflows in the country is less than the targeted investments and if so, the details and the reasons therefor; and
- (d) the details of FDI projects with investments during the last three years and the current year, State and department-wise?

ANSWER

वाणिज्य एवं उद्योग मंत्री (श्री पीयूष गोयल) THE MINISTER OF COMMERCE & INDUSTRY (SHRI PIYUSH GOYAL)

- (a): As per the United Nations Conference on Trade and Development (UNCTAD)'s World Investment Report (WIR) 2017, 2018 & 2019, India has been in the top ten FDI hosting countries during each of the last three years.
- (b): No such data on FDI projects or MoUs is centrally maintained.
- (c): Government does not fix targets for FDI inflows as FDI is largely a matter of private business decisions. FDI inflows depend on a host of factors such as availability of natural resources, market size, infrastructure, general investment climate as well as macro-economic stability and investment decisions of foreign investors.
- (d): The State and department-wise information on FDI projects is not centrally maintained. However, sector-wise details are at Annexure-I.
