FUNDS SPENT ON SKILLING THE YOUTH

296. SHRI VINCENT H. PALA:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the number of youth trained and skilled under the various Skill Development programmes/schemes during the last two years, State/UT-wise;
- (b) the amount allotted and the funds spent on skilling the youths during the said period, State/UT-wise;
- (c) the numbers targeted to skill the youths every year and the achievement made, State/UT-wise during the said period; and
- (d) the numbers of skilled and employed youths every year during the said period, State/UT-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI R. K. SINGH)

(a) to (d) Under Skill India Mission, the Government is implementing various schemes for imparting employable skills to the youth through short term and long term training. There are more than 20 central ministries/departments running schemes/programmes to impart skill training to the youth of the nation. As per the information provided by various Central Ministries/departments (including data of Ministry of Skill Development and Entrepreneurship institutions), more than 95.67 Lakh and 85.98 Lakh persons have been trained during 2017-18 and 2018-19 respectively. Ministry of Skill Development and Entrepreneurship (MSDE) is implementing a flagship scheme known as Pradhan Mantri Kaushal Vikas Yojana (PMKVY 2.0) 2016-20 on pan-India basis with a target to provide skilling to one crore people under Short Term Training (STT), Recognition of Prior Learning (RPL) and Special Project (SP) across the country over four years (2016-2020) with an outlay of Rs.12,000 crore.

PMKVY 2.0 has two components known as Centrally Sponsored Centrally Managed (CSCM) being implemented by National Skill Development Corporation (NSDC) and Centrally Sponsored State Managed (CSSM) being implemented by State Skill Development Missions of the States/ UTs popularly known as State- Engagement Component of PMKVY (2016-20). Under CSCM component of PMKVY 2016-20, there is no provision of State-wise funds allocation. The total funds amounting to Rs. 1132.48 Cr. and Rs. 1887.96 Cr. have been spent during FY 2017-18 and FY 2018-19, respectively. So far, based on the data available as on 12.06.2019, over 27 lakh people have been trained and over 11 lakh persons have been placed under STT component of PMKVY 2.0. The state-wise details of candidates trained and placed under STT component of PMKVY 2016-20 are placed at Annexure-I and the state-wise details of candidates assessed under RPL component of PMKVY 2016-20 are placed at Annexure-II.

Further, under CSSM component of PMKVY 2016-20, 25% of the funds and corresponding physical targets of PMKVY 2016-20 has been allocated to the States for imparting skill development training. The total funds amounting to Rs. 588.70 Cr. and Rs. 21.23 Cr. have been spent during FY 2017-18 and FY 2018-19, respectively.

Long term training is provided through Industrial Training Institutes (ITIs). Under this, 12.17 Lakh and 14.48 Lakh trainees are admitted in ITIs under Craftsmen Training Scheme during the FY 2017-18 and FY 2018-19 respectively.
