PROMOTION OF TOURISM IN KANYAKUMARI

299. SHRI H. VASANTHAKUMAR:

Will the Minister of TOURISM be pleased to state:

- (a) whether the Government is aware that number of tourists visiting Kanyakumari District from within the country and abroad increases year after year;
- (b) if so, the details thereof during the last three years, year-wise and the revenue earned from tourism;
- (c) whether the Government is aware of the long pending projects to promote tourism and beautify beaches/basic amenities to the tourists in Kanyakumari District;
- (d) if so, the action taken by the Government; and
- (e) if not, the reasons therefor?

ANSWER

MINISTER OF STATE FOR TOURISM (INDEPENDENT CHARGE) (SHRI PRAHLAD SINGH PATEL)

(a) and (b): Ministry of Tourism, Government of India compiles the State/UT-wise figures of Domestic Tourist Visits (DTVs) and Foreign Tourist Visits (FTVs) on the basis of information provided by State Governments and UT Administrations. The figures of DTVs and FTVs in the State of Tamil Nadu during 2015, 2016 and 2017 (latest available) are as follows:

Ministry does not compile the figures of revenue earned from tourism. However, the estimated Foreign Exchange Earnings (FEEs) through tourism in India during the last three years are as follows:

(c) to (e): Development and promotion of tourist places is primarily Government/UT responsibility of concerned State Administration. However, the Ministry of Tourism promotes India as a holistic destination covering its various tourism destinations and products across different States/Union Territories in the country. For creation of tourism infrastructure in the country, the Ministry of Tourism has two flagship schemes viz. Swadesh Darshan -Integrated Development of Theme-Based Tourist Circuits and Rejuvenation PRASHAD-Pilgrimage and Spiritual, Heritage Augmentation Drive. The projects under these schemes for development in consultation with the Governments/UT Administrations and are sanctioned subject to availability of funds, submission of suitable detailed project reports, adherence to scheme guidelines and utilization of funds released earlier.
