TOLL GATES IN TAMIL NADU

3023. SHRI SELVAM. G.:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS सडक़ परिवहन और राजमार्ग मंत्री

be pleased to state:

- (a) the total number of toll gates on the National Highways in Tamil Nadu (TN);
- (b) whether the revenue generated through each such toll gate in TN has increased during each of the last three years and the current year;
- (c) if so, the details thereof, toll gate-wise;
- (d) whether the toll gates established by the State Governments are notified by the Union Government and if so, the details thereof;
- (e) whether the Union Government has fixed any time limit for the entry and exit at toll gates in Tamil Nadu and if so, the details thereof; and
- (f) the measures being taken by the Union Government to ensure that all toll roads are fit for smooth travel?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

(a) The total number of user fee plazas operational on National Highways in the state of Tamil Nadu are 52.

(b) &(c) Yes, Sir. The revenue generated through fee plazas under Public Funded Projects in Tamil Nadu has increased during each of the last three years. The details are at **Annexure-A**.

(d) Yes, Sir. In cases where a particular stretch of National Highway is entrusted to a State Government/ Union Territory (UT), the executing agency of the concerned State Government/ UT complies with the notification issued by the Central Government.

(e) At present, as per Rule 9(2) of the National Highways Fee (Determination of Rates & Collection) Rules, 2008, user fee at the rate of one & half times of the fee applicable for one way journey is payable for two one way journey through a fee plaza within a period of 24 hours from the time of payment.

(f) All National Highways are being maintained in traffic worthy condition through Operation & Maintenance (O&M) contractor in Public Funded projects and by Build Operate & Transfer (BOT) / Operation Maintenance & Transfer (OMT) Concessionaire in Public Private Partnership (PPP) projects.
