Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Government is satisfied with the implementation of various schemes for development of Micro, Small and Medium Enterprises (MSMEs);
- (b) if so, the details thereof;
- (c) whether loan based capital subsidy scheme is being implemented for technological upgradation of MSMEs of the country;
- (d) if so, the details thereof; and
- (e) the number of MSMEs covered under this scheme in the Country during the last three years and the current year, State/UT-wise including Maharashtra?

(a)&(b): Ministry of Micro, Small and Medium Enterprises (MSME) implements different schemes and programmes aimed at promotion and development of Micro, Small and Medium Enterprises (MSMEs). These include the schemes/programmes such as Prime Minister's Employment Generation Programme (PMEGP), Scheme of Fund for Regeneration of Traditional Industries (SFURTI), A Scheme for Promoting Innovation, Rural Industry and Entrepreneurship (ASPIRE), Credit Guarantee Scheme, Credit Linked Capital Subsidy Scheme (CLCSS), Micro and Small Enterprises - Cluster Development Programme (MSE-CDP), etc.

(c)to(e): Ministry of MSME implements a Credit Linked Capital Subsidy Scheme (CLCSS) across the country. The Scheme facilitates technology up-gradation for MSEs by providing capital subsidy up to a maximum limit of Rs 15.00 lakhs. The number of MSEs benefitted under the scheme in the Country during the last three years and current year, State/UT-wise including Maharashtra, is given in Annexure.
