#### FUNCTIONING OF COOPERATIVE BANKS

#### 3487. SHRI ANTO ANTONY:

Will the Minister of FINANCE be pleased to state:

- (a) whether the Government has any role or control over the functioning of cooperative banks in the country, if so, the details thereof;
- (b) whether the Government has any statistics regarding number of co-operative banks functioning in the country, if so, the details thereof, State-wise; and
- (c) whether it is mandatory that the details of the depositors are to be shared with Government of India and if so, the details thereof?

#### **ANSWER**

# THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI ANURAG THAKUR)

- (a) National Bank for Agriculture and Rural Development (NABARD) has reported that the functioning of Cooperative Banks is guided by the Cooperative Societies Act of the respective States. At the State level, the Registrar of Cooperative Societies (RCS) of respective States exercises control over the Cooperative Banks. However, the banking functions of the Cooperative Banks are regulated by Reserve Bank of India under the Banking Regulation Act, 1949 (as applicable to Cooperatives).
- (b) The list of Cooperative Banks functioning in the country as reported by NABARD and Reserve Bank of India (RBI) is given in Annexure I to IV.
- (c) RBI has informed that in terms of its Master Direction dated 25.02.2016 on Know your customer (KYC), all entities regulated by RBI including Cooperative Banks are required to share/submit details of transaction/accounts as required under the Prevention of Money Laundering (Maintenance of Records) Rules, 2005 with Financial Intelligence Unit-India (FIU-IND).
