3769. SHRIMATI KANIMOZHI KARUNANIDHI:

Will the Minister of PANCHAYATI RAJ be pleased to state:

- (a) whether the Government has received representation from the State Government of Tamil Nadu for release of the pending performance grant for 2017-18 and 2018-19 as per 14th Finance Commission recommendations;
- (b) if so, the details thereof;
- (c) the details of the grant allocated to Tamil Nadu for rural development during the last five years; and
- (d) the reasons for not releasing the performance grant on time as per the recommendation of the 14th Finance Commission?

ANSWER

THE MINISTER OF PANCHAYATI RAJ (SHRI NARENDRA SINGH TOMAR)

- (a) & (b) Yes Sir. The details are provided at **Annexure I**. Holding election of local bodies in the State is a pre-condition for recommendation for release of the Fourteenth Finance Commission (FFC) Grants, this is pending for Tamil Nadu since October, 2016.
- (c) The details are provided at **Annexure II**.
- (d) In the absence of duly constituted Gram Panchayats by elections, FFC Performance Grant could not be recommended for release to the State of Tamil Nadu, after FY 2016-17.
