AADHAAR CARD LINK WITH RATION CARDS

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले , खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) whether the process of linking e-ration cards with Aadhaar card under National Food Security Act (NFSA) has helped in cancellation of a number of bogus ration cards;
- (b) if so, the details thereof; and
- (c) the details of the ration cards issued linked with Aadhaar and found bogus in respect of the State of Maharashtra, so far?

- (a) & (b): Department is implementing a Scheme on "End-to-end Computerization of TPDS Operations" in collaboration with all States/UTs on cost sharing basis. The Scheme comprises activities, namely, digitization of ration cards/beneficiary and other databases, computerization of supplychain management, setting up of transparency portals and grievance redressal mechanisms. The Digitization of ration cards/ beneficiaries data has been completed in all 36 States & UTs and digitized details of Ration Cards are available on transparency portals of States/UTs. Apart from the above, in order to identify and weed-out duplicate/ineligible beneficiaries from the TPDS, and to enable better targeting of food subsidies - States/UTs have been asked to seed the Aadhaar number in ration cards/beneficiaries database. At present, 85.5% Ration Cards (at least one member of family) are seeded with Aadhaar number. The bogus ration cards have been identified/detected due to digitisation of ration cards, de-duplication due to seeding of Aadhaar numbers in digitised PDS database, apart from adoption of other means such as detection of in-eligible beneficiaries/families, transfer/migration of families, death(s), change in the economic status of the household etc and has resulted in the deletion/cancellation of ghost/ineligible ration cards. As per the information, a total of 2.98 crore ration cards stand deleted/cancelled by States/UTs during 2013-18.
- (c): The details of ration cards issued, linked with Aadhaar and found bogus in respect of State of Maharashtra is at Annexure.
