REVIEW OF SKILL DEVELOPMENT PROGRAMME

395. SHRI PANKAJ CHAUDHARY:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether the Government proposes to review the Skill Development and Entrepreneurship programmes;
- (b) if so, the details thereof;
- (c) the measures being taken by the Government for early resolution of the issues raised by State Governments to remove some shortcomings in the Skill Development training process; and
- (d) the details of the funds being provided by the Government for Skill Development training during the year 2018- 19 State/UT-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI R. K. SINGH)

(a) to (d) Under Skill India Mission, the Government is implementing various schemes/programme for imparting employable skills to the youth through short term and long term training. The National Skill Development Mission (NSDM) was launched by the Hon'ble Prime Minister on 15th July, 2015, to provide a strong institutional framework to implement and scale up skill development efforts across the country and to impart training to one crore youth every year. Under this, more than 20 central ministries/departments are running schemes/programmes to impart skill training to the youth of the nation.

The progress of schemes/programme under the National Skill Development Mission (NSDM) has been regularly reviewed by the Government. The Mission has been able to ensure convergence, coordination and harmonization across programs of various Ministries in Government of India and other key stakeholders like State Government, Industry, Training ecosystem etc. through Common norms, implementation of National Skills Qualification Framework (NSQF), data integrations through the Skill India Portal and quality assurance through the SMART (Skill Management and Accreditation of Training Centre) portal.

Ministry of Skill Development And Entrepreneurship has two components in its flagship program- the Pradhan Mantri Kaushal Vikas Yojana 2.0 (PMKVY 2.0) (2016-2020) viz Centrally sponsored Centrally Managed (CSCM) being implemented by National Skill Development Corporation (NSDC) and Centrally Sponsored State Managed (CSSM) being implemented by State Skill Development Missions of the States/UTs. Under CSCM component of PMKVY 2016-20, there is no provision of State-wise funds allocation. Total funds amounting to Rs. 1887.96 Cr. have been spent during FY 2018-19..

However, under CSSM component of PMKVY 2016-20, 25% of the funds and corresponding physical targets of PMKVY 2016-20 has been allocated to the States for imparting skill development training. The State-wise detail of fund approved for the FY 2018-19 is in **Annexure.**
