4286. SHRI CHANDESHWAR PRASAD:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS सडक परिवहन और राजमार्ग मंत्री

be pleased to state:

- (a) the funds allocated by the Union Government to various States including Bihar for maintenance of National Highways (NHs) during the last two years and the current year, State/UT-wise;
- (b) the details of the work undertaken by the Government of Bihar in this direction along with the funds utilised by it during the said period; and
- (c) the steps taken by the Union Government for adequate utilisation of the said funds?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS (SHRI NITIN JAIRAM GADKARI)

- (a) The funds allocated by the Union Government to various States including Bihar for maintenance of National Highways (NHs) during the last two years and the current year, State/UT-wise is annexed.
- (b) The works under periodical renewal, flood damage repairs and ordinary repairs have been undertaken by Government of Bihar and funds of Rs. 97.29 Crore, Rs. 20.92 Crore and Rs. 0.02 Crore have been utilized during 2017-18, 2018-19 and 2019 -20 (till May, 2019) respectively.
- (c) Quarterly critical review meetings are taken up by the Union Government at various levels for adequate utilization of the above said funds. Besides this, Regional Officers of this Ministry placed in various states for regular inspection and monitoring the proper utilization of funds.
