Will the Minister of TEXTILES वस्त्र मंत्री  
be pleased to state:

- (a) the time since the scheme for Integrated Textile Park is operational in the country;
- (b) whether the Ministry have received any proposals from State Government of Andhra Pradesh for providing financial assistance in setting up of textile parks/ integrated textile park in the State, if so, the total grants sanctioned to them in the last two financial years under Scheme for Integrated Textile Park (SITP);
- (c) the number of apparel parks functioning in the country, State-wise and the status of these parks including SITP in Andhra Pradesh in terms of employment generation;
- (d) whether the Government can subsume the proposed State Government textile park, for which 90 acres of land is earmarked at Banavasi Village of Yemmiganur Mandal of Kurnool district of Andhra Pradesh State; if so, the details thereof and the necessary procedures that need to be undertaken;
- (e) whether the Government has taken steps to install more Common Effluent Treatment Plants (CETPs) in the textile industry in the country, if so, the details thereof, State-wise; and
- (f) whether the Government proposes to establish more textile parks in the country including the state of Gujarat, if so, the details thereof and the time by which these textile parks are likely to be set up?

**(a) to (b):** . The Scheme for Integrated Textile Park (SITP) was approved during the 10<sup>th</sup> Five Year Plan in 2005. Five (5) Textile Parks have been sanctioned so far, under SITP in the state of Andhra Pradesh. A sum of Rs.4.75 crores have been released to these Textile Parks during the last two years and the current year.

**(c):** There are a total of 59 textile parks approved under SITP by the Ministry. Although, there are no specific apparel parks under SITP, there are 36 Textiles Parks which have apparel units under them. Status of Textile Parks

in Andhra Pradesh under the SITP in terms of employment generation is at Annexure A.

**(d):** No, Sir. The scheme guidelines for SITP does not have any such provision.

**(e):** This Ministry is implementing the Integrated Processing Development Scheme (IPDS) for enabling the textile processing sector to meet environmental standards through adoption of appropriate technology, specifically in the area of water and waste water management. The Scheme is a demand driven scheme. This Ministry has sanctioned 7 Projects under the IPDS for setting up 'Common Effluent Treatment plants' (CETPs) with Zero Liquid Discharge (ZLD) systems out of which 3 projects are in the state Rajasthan, 3 projects are in the state of Tamil Nadu and 1 project is in the state of Gujarat. Also, required CETPs may be included in SITP proposal under 'Common Facility' component.

**(f):** Scheme for Integrated Textile Park is a demand driven scheme in which the prospective entrepreneurs can send their proposals to the Government, after completion of stipulated conditions as per guidelines. The Textile Parks under SITP approved in the state of Gujarat are given in Annexure-B.
