4645. SHRI UPENDRA SINGH RAWAT:

Will the Minister of FINANCE be pleased to state:

- (a) the total number of sanctioned/working strength of Scale I to Scale III officers of Central Bank of India (CBI), Region-wise;
- (b) whether there is shortage of Scale I to Scale III officers in CBI and if so, the details thereof and the reasons therefor;
- (c) the number of Scale I to Scale III officers in CBI who are unofficially working in the Department of Financial Service and getting their salary from the CBI to avoid their out of Delhi posting during the last four years; and
- (d) The steps taken/efforts made by the CBI to repatriate such Scale I to Scale III officials?

**(a) & (b):** As informed by Central Bank of India (CBI) the sanctioned strength, officers in place & net shortage for Scale I/II/III officers in Central Bank of India for the year 2019-20 is as under:

	Scale I	Scale II	Scale III
Sanctioned Strength	1725	1684	1132
Vacancies filled through Promotional Process	774	510	377
Net Shortage	951	1174	755

The promotional process for the year 2019-20 and the posting of officers in various Scales in the Branches / Offices in Regions is in progress.

**(c) & (d):** The Department of Financial Services (DFS), inter-alia, deals with issues relating to Banking, Insurance, Pension Reforms which are very technical in nature and therefore often require expertise and experience from the practitioners in the banking system. Considering this, the services of staff including female staff of various Public Sector Banks are utilized, as and when required. The Department is also implementing a large number of important schemes such as Pradhan Mantri Jan Dhan Yojana (PMJDY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Mudra Yojana (PMMY), Atal Pension Yojana (APY), Stand Up India etc. The Department is also coordinating MSME Support and Outreach campaign. Considering the fact that all these schemes require continuous and close coordination with banks/financial

institutions, therefore the services of some officials from Banks are utilized from time to time to resolve technical matters. Their assignment in DFS is, therefore, non-permanent in nature. Currently, three officers of CBI are working in DFS.
