**Setting Up of Medical Colleges by CIL**

**5246. SHRI CHANDRA PRAKASH JOSHI:**

Will the Minister of COAL be pleased to state:

- (a) whether Coal India Limited and its ancillary companies are running medical college, hospital, dispensary and educational institutions in the country;
- (b) if so, the details thereof, location and State/UT-wise?
- (c) whether the Government has acquired land for setting up of medical colleges by Coal India Limited and its ancillary companies;
- (d) if so, the details thereof; and
- (e) the time by which these colleges are likely to be made functional along with the amount likely to be spent in this regard?

(a) & (b) : Coal India Limited and its subsidiaries are not running any medical college and educational institutions. However, hospitals and dispensaries are being run by Coal India Limited and its subsidiaries to meet the medical requirements of its employees and their families. Subsidiaries of CIL have entered into an agreement with institutions viz. Central School, DAV, Delhi Public School etc. for setting up of schools in their command areas and aids are provided for running the schools. The location of Hospitals, Dispensaries etc. State/UT wise are as under:
