### **Areas facing Drinking Water Crisis**

#### †5333. SHRIMATI RANJAN BEN DHANANJAY BHATT:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether there are several places in every State of the country which are facing problem of pure drinking water as on date;
- (b) if so, whether the Government proposes to take any steps to obtain information in this regard;
- (c) if so, the details thereof; and
- (d) if not, the reasons therefor?

# ANSWER MINISTER OF STATE FOR JAL SHAKTI (SHRI RATTAN LAL KATARIA)

(a) to (d) Rural Drinking water supply is a State subject. For improving the coverage of safe drinking water to rural population, this Ministry supplements the efforts of the States by providing them with technical and financial assistance through the centrally sponsored scheme National Rural Drinking Water Programme (NRDWP). It is the State Governments who plan, design, approve, execute, operate & maintain Water Quality Testing Laboratory (WQTL) for ensuring safe drinking water to rural population.

Under the Centrally Sponsored National Rural Drinking Water Programme (NRDWP) guidelines, upto 5% of NRDWP coverage funds can be used by states for Water Quality Monitoring and Surveillance (WQM&S) activities which inter-alia includes water quality testing at different levels as per guidelines.

As reported by States in the Integrated Management Information System (IMIS) of this Ministry, the State-wise and Contamination-wise details of water quality affected rural habitations are placed at **Annexure**.
