Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the quantum of financial assistance provided by the Union Government to State Governments/Union Territories for setting up and maintenance of Child Care Institutions; and
- (b) whether certain States have failed to utilize the sanctioned amount, if so, the details thereof?

- (a) & (b): The Ministry of Women and Child Development is implementing centrally sponsored scheme i.e. "Child Protection Services" (CPS) (erstwhile Integrated Child Protection Scheme), for care, protection, rehabilitation and reintegration of children in difficult circumstances. Under CPS, financial assistance is provided to State Governments/UT Administrations, for setting up and maintenance of various types of Child Care Institutions (CCIs) for providing various rehabilitative services through Institutional and Non-Institutional care. The details of funds released and utilized by the State Governments/UT Administrations under CPS are **Annexed**.
