STORAGE FACILITIES IN RURAL AREAS

559. DR. RAMAPATI RAM TRIPATHI:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether the Government proposes to provide storage facilities in the rural areas of the country under the rural storage yojana/Gramin Bhandaran Yojana;
- (b) if so, the details thereof, State-wise; and
- (c) the total number of rural godowns constructed during each of the last three years and the number of farmers benefited under the scheme, the details thereof, State-wise including Uttar Pradesh?

ANSWER

- (a) & (b): Yes Sir. The Government is promoting storage facilities in rural areas of the country through the scheme of "Agricultural Marketing Infrastructure (AMI)", which is a subscheme under the Integrated Scheme for Agricultural Marketing (ISAM). AMI scheme is a back ended capital subsidy scheme in which rate of subsidy provided is 25% and 33.33% based on the category of eligible beneficiary and provided on capital cost of the project. Assistance under the sub-scheme is available to individuals, groups of farmers/growers, registered Farmer Produce Organizations (FPOs) etc. So far, a total of 38,964 storage infrastructure projects (Godowns), with storage capacity of 655.48 Lakh MT have been sanctioned across the country in rural areas. The State wise details are at Annexure-I.
- (c): During last three years, a total of 2743 storage infrastructure projects (Godowns) have been assisted with storage capacity of 74.16 Lakh MT under storage component of AMI subscheme directly benefiting number of agripreneurs including farmers. The State-wise details are at Annexure II. The scheme is demand driven and no scientific storage facility in Uttar Pradesh has been sanctioned during the last three years.
