Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) the details of the welfare schemes intended for the benefits of the persons belonging to the minority communities in the country;
- (b) whether the Government has any monitoring mechanism to check the implementation of such schemes;
- (c) if so, the details thereof and if not, the reasons therefor;
- (d) the funds allocated and utilized for such schemes during each of the last three years and the current year, Scheme-wise and State/UT-wise;
- (e) whether the cases of irregularities and corruption in the implementation of such schemes have come to the notice of the Government during the said period; and
- (f) if so, the details thereof along with the remedial measures taken/being taken by the Government in this regard?
