(a): The Ministry is implementing (Samarth) - Scheme for Capacity Building in Textile Sector (SCBTS), with the objective to provide demand driven, placement oriented National Skill Qualification Framework (NSQF) compliant skilling programmes to incentivize and supplement the efforts to the industry in creating jobs in the organised textile (excluding spinning & weaving) and related sectors and to provide skilling and skill-upgradation in the traditional sectors. Samarth was initially approved for implementation from 2017-18 to 2019-20 on 20thDecember 2017. Guideline of the scheme was issued on 23.04.2018. Further, the scheme has been extended up to 31.03.2024. Samarth Scheme was formulated under the broad skilling framework adopted by M/o Skill Development & Entrepreneurship. The scheme is implemented and monitored through a robust digital platform linked with Aadhaar Enabled Biometric Attendance System (AEBAS). A total of 106 Textile Manufacturers, 12 Industry Associations, 15 State/Central government agencies and 4 sectoral organizations have been on-boarded under the scheme with an allocated target of 4.17 lakh beneficiaries. A total of 1,31,161 beneficiaries have been trained, of which 79,999 have been provided placement.

(b): The State wise details of total beneficiaries including the states of Uttar Pradesh, Himachal Pradesh and Rajasthan under Samarth scheme is given at Annexure.

(c): The details of fund utilized during the operation of Samarth scheme is as under:

(d) & (e): Samarth is a Pan India scheme implemented on demand driven basis to address the skilled manpower needs of textile sector. In addition to allocating targets to textile industry and Sectoral Organizations, all State Governments including States of Uttar Pradesh, Himachal Pradesh and Rajasthan were requested for proposals for participation under the scheme. The details of Samarth Programmes with details of participation of state agencies and other implementing partners in these States are given below:
