Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether the Government has undertaken various works under the Pradhan Mantri Krishi Sinchayee Yojana (PMKSY);
- (b) if so, the details of physical and financial progress made under PMKSY during the last three years, State-wise;
- (c) the details of works carried out and target set under Har Khet Ko Pani component of PMKSY, Statewise including Madhya Pradesh, Uttar Pradesh and Maharashtra;
- (d) the number of irrigation projects that have been identified and completed under PMKSY so far, State-wise;
- (e) whether the Government has conducted any study to ascertain the impact of the scheme on the agricultural production in the country along with the number of farmers benefited so far under PMKSY, and if so, the details thereof, State/UT-wise; and
- (f) the other steps taken/being taken by the Government for effective monitoring and implementation of the PMKSY?

# STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (f) OF STARRED QUESTION NO. \*34 TO BE ANSWERED ON 08.12.2022 IN LOK SABHA REGARDING "WORKS UNDER PMKSY"

(a) Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) was launched during the year 2015-16 to enhance physical access of water on farm and expand cultivable area under assured irrigation, improve on-farm water use efficiency, introduce sustainable water conservation practices, etc.

PMKSY is an umbrella scheme, consisting of two major components being implemented by the Department of Water Resources, River Development & Ganga Rejuvenation, Ministry of Jal Shakti, namely, Accelerated Irrigation Benefit Programme (AIBP), and Har Khet Ko Pani (HKKP). HKKP, in turn, consists of four subcomponents: (i) Command Area Development & Water Management (CAD&WM); (ii) Surface Minor Irrigation (SMI); (iii) Repair, Renovation and Restoration (RRR) of Water Bodies; and (iv) Ground Water (GW) Development. In 2016, with the launching of revised AIBP format, CAD&WM sub-component of HKKP was taken up for pari passu implementation with AIBP.

In addition, PMKSY consists of two other components implemented by other Ministries. Per Drop More Crop (PDMC) component is being implemented by Department of Agriculture and Farmers Welfare, while Watershed Development component (WDC) of PMKSY is being implemented by Department of Land Resources.

Further, in December, 2021, implementation of PMKSY for the period 2021-22 to 2025-26 has been approved by Government of India with an overall outlay of Rs. 93,068.56 crore (central assistance of Rs. 37,454 crore, debt servicing to NABARD for Rs. 20,434.56 crore and an outlay for Rs. 35,180 crore by the State Governments towards State share). However, approval of Ground Water component under PMKSY-HKKP has provisionally been accorded till 2021-22, which has been extended subsequently till completion of ongoing works. Also, Per Drop More Crop component, which was earlier a component of PMKSY, is now being implemented separately.

Details of physical and financial progress made under PMKSY during the last three years, State-wise is given in **Annexure-I.** 

(c) For the period 2021-26, PMKSY-HKKP has been approved with the target for creation of 4.5 lakh hectare of irrigation potential through surface minor irrigation and repair, renovation and restoration of water bodies. Implementation of ground water component for completion of ongoing projects with irrigation potential of 82,290 hectare has also been provisioned. Further, CAD&WM component of PMKSY being implemented pari passu with AIBP targets completion of 85 ongoing CAD&WM major/ medium projects with coverage of cultivable command area of 30.23 lakh hectare during 2021-22 to 2025-26.

Works done under the different sub-components of PMKSY-HKKP during 2015-16 to 2021-22 in various States, including Madhya Pradesh, Uttar Pradesh and Maharashtra, are given at **Annexure-II.** 

- (d) Component-wise details of number of projects identified for funding and completed under PMKSY so far, State/UT-wise, are given in Annexure-III.
- (e) Development Monitoring and Evaluation Office (DMEO) under NITI Ayog has carried out evaluation of PMKSY for the period 2015-2020. Most components of PMKSY have been ranked as satisfactory in terms of relevance, efficiency, impact and equity parameters of the performance.

Further, "The Performance and Impact of Micro Irrigation in Improving Water Use Efficiency in India's Agriculture: Study of the PMKSY-PDMC" has been carried out by Indian Institute of Management, Ahmedabad in the year 2021. It considered sample surveys in Maharashtra, Telangana, Uttar Pradesh, Madhya Pradesh and Sikkim. The study indicates that on an average there is 23% increase in the area irrigated through

micro irrigation than the conventional methods of irrigation in the area. The study has also concluded that production of the crop has increased substantially, to the tune of about 73%, with improved quality produce resulting in increase in sales revenue.

24.35 lakh hectare additional irrigation potential has been created during 2016-22 through PMKSY-AIBP while 5.58 lakh hectare additional irrigation potential has been created under PMKSY-HKKP. Considering 1.08 hecatre of average size of operational holding identified by the irrigation census 2015-16, it is estimated that about 28 lakh farmers are benefitting through these schemes.

(f) The State Governments are mandated to monitor and ensure maintenance and quality control of irrigation projects implemented by them. In addition, the projects are regularly monitored by Central Water Commission, as well as by a dedicated Project Management Unit (PMU) under the Ministry of Jal Shakti. Physical and financial progress of these projects is also monitored through a dedicated dashboard, backed with a management information system maintained by this Ministry.

Apart from the above, implementation and progress of the projects is also monitored at the highest level in this Ministry.

As per guidelines of AIBP, a special cell for monitoring of the bottlenecks, and grievances pertaining to the projects receiving financial assistance under PMKSY-AIBP, has been provisioned. Further, third party evaluation of completed projects is also undertaken by this Ministry on sample basis.
