DEVELOPMENT OF INLAND WATERWAYS

*46 SHRI LORHO S. PFOZE:

Will the Minister of PORTS, SHIPPING AND WATERWAYS be pleased to state: पत्तन, पोत परिवहन और जलमार्ग मंत्री

- (a) whether the Government is developing any inland waterways with suitable ports in North East India along the river Brahmaputra;
- (b) if so, the details thereof;
- (c) whether the Government is considering inland waterway development in smaller river systems including the river Barak; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF PORTS, SHIPPING AND WATERWAYS (SHRI SARBANANDA SONOWAL)

(a) to (d) A statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF LOK SABHA STARRED QUESTION NO. *46 FOR 09.12.2022 RAISED BY SHRI LORHO S. PFOZE, HON'BLE M.P. ON "DEVELOPMENT OF INLAND WATERWAYS".

(a) & (b) Yes, Sir. Inland Waterways Authority of India (IWAI) an autonomous organisation under the Ministry of Ports, Shipping and Waterways (MoPSW) has taken up development of National Waterway -2 (NW-2) i.e. River Brahmaputra from Dhubri to Sadiya (891 km). The waterway is operational for movement of cargo and passenger vessels. The waterway is maintained with navigable fairway, day navigation marks in entire 891 km stretch and night navigational aids in Dhubri-Silghat (440 km) stretch. A multimodal (MMT) river port at Pandu with road and rail connectivity and another permanent terminal at Dhubri has been constructed. 11 nos. of floating terminals are also provided on NW-2. Construction of a new terminal at Jogighopa has been taken up and construction of a cargo cum tourist terminal at Bogibeel (Dibrugarh) has also been approved.

(c) &(d) Yes, Sir. The proposal for development of river Kopili (National Waterway-57) and river Dhansiri (National Waterway -31) has been approved. Further development of river Barak (121 Km) (National Waterway-16) has been taken up by IWAI. Major activities include fairway development, upgradation of terminal at Badarpur and Karimganj, navigational aids etc. Ministry of Ports, Shipping & Waterways has a Central Sector Scheme under which 100% grant is provided to North Eastern States for development of Inland Waterways. The different ongoing projects under the scheme are given at Annexure-1.
