# LOK SABHA STARRED QUESTION No.51 TO BE ANSWERED ON 9<sup>TH</sup> DECEMBER, 2022

#### **AYUSH CENTRES**

### \*51.SHRIMATI BHAVANA PUNDALIKRAO GAWALI: SHRI GAJENDRA SINGH PATEL:

Will the Minister of AYUSH be pleased to state:

- (a) the State-wise details of number of AYUSH Health and Wellness Centres/Hospitals in the country along with the number of National level Institutes/ Health Centres in Maharashtra and Madhya Pradesh;
- (b) the steps taken by the Government to expand the facilities at these Centres;
- (c) the manner in which the Government has conceptualized setting up of AYUSH Centres for improving the health and wellness of the citizens;
- (d) the manner in which the AYUSH scheme has been implemented in Vidarbha and Marathwada regions of Maharashtra and the achievements made so far;
- (e) whether the Government plans to promote AYUSH systems of medicine internationally along with the steps taken in this regard; and
- (f) whether the Government proposes to open new AYUSH Centres in the country including tribal areas of Madhya Pradesh and if so, the State/ UT-wise details thereof?

#### **ANSWER**

### THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) to (f) A Statement is laid on the Table of the House.

### THE STATEMENT REFERRED TO IN REPLY TO LOK SABHA STARRED QUESTION NO.51 FOR 9<sup>TH</sup> DECEMBER, 2022.

- (a) The State-wise details of number of AYUSH Hospitals and AYUSH Health and Wellness Centers as approved under Centrally Sponsored Scheme of National AYUSH Mission (NAM) in the country is furnished in Annexure-I. Further, National Institute of Naturopathy (NIN), Pune, an autonomous organization under Ministry of Ayush is functioning in the State of Maharashtra. However, no National level Institutes/Health Centers is functioning in the State of Madhya Pradesh under control of Ministry of Ayush.
- (b) Government of India is implementing Centrally Sponsored Scheme of National AYUSH Mission (NAM) through State/UT Governments and supporting their efforts to expand the facilities in these centers through different activities like upgradation of existing AYUSH dispensaries & sub health centers as AYUSH Health and Wellness Centers, as well as upgradation of AYUSH Hospitals, by providing infrastructure, supply of essential AYUSH Drugs and deployment of manpower. State/UT Governments may avail the eligible financial assistance by submitting suitable proposals through State Annual Action Plans (SAAPs) as per the NAM guidelines.
- (c) The AYUSH systems advocate the holistic wellness approach aiming at prevention of diseases and promotion of health and wellbeing. The main objectives are to establish a holistic wellness model based on AYUSH principles and practices, to empower masses for "self-care" to reduce the disease burden, out of pocket expenditure and to provide informed choice to needy public. The health care facilities to be upgraded as AYUSH HWCs are AYUSH dispensaries and sub health centres. The Ministry of Ayush has been given the task of developing 12,500 HWCs in a phased manner in consultation with States/UTs and Ministry of Health & Family Welfare.
- (d) Under NAM, 177 AYUSH Health and Wellness Centers have been approved in Vidarbha and 151 are functional. Similarly, 30 AYUSH Health and Wellness Centers have been approved in Marathwada region and 25 are functional.
- (e) The Ministry has developed a Central Sector Scheme for the Promotion of International Cooperation in AYUSH (IC Scheme) under which the Ministry of Ayush provides support to Indian AYUSH Manufacturers/ AYUSH Service providers to give boost to the export of AYUSH products & services; facilitates the International promotion, development and recognition of AYUSH system of medicine; foster interaction of stakeholders and market development of AYUSH at international level; promote academics and research through the establishment of AYUSH Academic Chairs in foreign countries and holding training workshop/symposiums for promoting and strengthening awareness and interest about AYUSH Systems of Medicine at international level.
- (f) Public Health being a State subject, the opening of new AYUSH centers comes under the purview of respective State/UT Governments including tribal area of Madhya Pradesh. However, under the Centrally Sponsored Scheme of National AYUSH Mission (NAM), there is a provision of financial assistance for setting up of 50 /30 /10 bedded integrated AYUSH hospitals in the country including Madhya Pradesh which also covers the tribal areas. The details of units approved in the country including Madhya Pradesh for setting up of upto 50 bedded integrated AYUSH hospitals from 2014-15 to 2021-22 is furnished at Annexure-II.
